## NOTIFICATION FOR **2ND PHASE OFFLINE (MANUAL) COUNSELING OF JEXPO-2019** TO FILL-UP REMAINING VACANT SEATS OF GOVERNMENT AND GOVERNMENT SPONSORED POLYTECHNICS

This is for information of all concerned candidates that an Offline (manual) Counseling of JEXPO-2019 will be conducted as per the schedule given here in under to fill-up the remaining vacant seats of Government and Government Sponsored Polytechnics. **Number of vacant seats are limited and vacancy status is available on the website, [www.webstate.co.in](http://www.webstate.co.in).**

Merit listed valid JEXPO 2019 candidates, who could not participate OR could not be allotted any seat OR could not take admission even after being allotted a seat in the Online Counseling due to different reasons and having **General Ranks** mentioned in the table below shall only be eligible for this Offline Counseling. **Candidates, who have already taken admission in any polytechnic through online counseling OR 1st phase offline counseling of JEXPO-2019, will not be eligible for this 2nd phase Offline (Manual) Counseling.** Seats will be allotted completely on the basis of general ranks in JEXPO-2019.

Willing eligible candidates must report **physically** at the counselling venue on the specified date and time and should bring with them the **admit card** of the entrance examinations along with all testimonials (including SC/ST/PC/OBC-A/OBC-B certificates) **in original**. However, medical fitness certificate and filled in anti-ragging formats have to be submitted at the time of admission to the allotted polytechnic.

Candidates will have to pay an amount of Rs.500/- (Rupees five hundred) only in CASH towards Seat Booking Fee at the counselling venue, if he/she is allotted a seat during Offline(Manual) Counseling. If, any candidate has already paid the seat booking fee during online counseling and produce the original payment document at the time of offline allotment of seats, he or she needs not to pay the said fee. Candidates who did not participate in the online counseling of JEXPO-2019, have to pay Rs.150/- (Rs.50/- for TFW/Kanyashree) in CASH towards counselling fee before taking part in the offline counseling.

**Please note that calling for counseling does not ensure allotment of seats. Allotment of a seat to a valid and eligible rank holder depends on his/her rank and availability of vacant seats at the time of his/her turn. Once again, it is reiterated that candidates, already admitted through online counseling or 1st phase offline counseling of JEXPO-2019, are not eligible for this 2nd phase offline (manual) counseling. Offline Counseling will continue till there will be availability of seat(s) and will be stopped when all eligible vacant seats will be allotted.**

**Once a seat is allotted to a candidate through manual counseling, the allotted seat cannot be changed or cancelled.**

All candidates and guardians, who will be present in the counselling program, are cordially requested to maintain discipline for smooth conduct of the counselling process.
