Students who have taken admission to the above-mentioned courses in the Academic Session 2020-21, will have to register themselves through "Online Registration (Academic Session 2020-21)" on the website www.webscte.co.in by providing necessary information. They have to fill in the registration form online, upload recent colour photo, upload scanned copy of original mark sheet, admit card & Kanyashree document (if applicable) and deposit the registration fee of Rs.200/- (Rs.100/- for Kanyashree) through online payment gateway (Debit Card / Credit Card / Net Banking / UPI). Finally, they have to submit the signed soft-copy of the registration application form (downloaded) and eligibility documents (scanned Mark sheet, Admit Card, Kanyashree document from originals) (all requisite documents to be scanned and duly converted to a single file in pdf file-format before submission) to their respective Institutes / Centers by email. There will be no collection of registration fee at the Institute Login" and they will have to validate registration of each and every student after due verification of the data provided by them. For the Kanyashree candidates, original document in respect of Kanyashree is to be verified at the Institute level prior to validation of registration.

In connection with the validation of applicants for online registration by the Institutes, it is pertinent to mention here that consequent upon the prevalent threat of the COVID-19, the submission of registration application form (downloaded) and eligibility documents (Mark sheet, Admit Card, Kanyashree document) has to be made ONLINE and not in person to the respective Institutes latest by 26-03-2021. All requisite documents to be scanned and duly converted to a single file in pdf file-format before submission. The file has to be named as the registration application form no. However, Institutes shall have to collect all such named files against each application of the registration at the institutes and to be mailed at entrancecell@webscte.co.in

User ID and Password will be sent to the email address of respective Institutes/
Centers. Institutes/Centers will have to validate the registration of the students through
Institute Login' latest by 30.03.2021. After completion of online validation,
Institutes/Centers will have to take a printout of the list of approved students (with photo) and
send the same along with all scanned signed soft-copies of registration application forms (tradewise) and eligibility documents of the students (scanned Mark Sheet, Admit Card, Kanyashree
document from originals) at the mail id entrancecell@webscte.co.in latest by 05.04.2021 with
a scanned forwarding letter under a folder in the name of the institute and strictly not
physically to Council office at 110, S.N. Banerjee Road, Kolkata-700013.

The Heads of the Institutes are also hereby requested to present the duly-signed undertaking-format on their Institute's Letter-Head, annexed to this notification, in respect of the courses in which the enrolment-strength not only less than the approved intake but also less than the Council prescribed minimum enrolment-strength of 10 (TEN). The undertaking is also to be mailed to the Council along with the documents related to registration within 05-04-2021.

Accordingly, concerned Institutes/Centers are requested to give a suitable notification on the notice boards advising their newly admitted students to participate in the online registration process within the specified last date. Online registration by the admitted students is mandatory. Registration certificate will be issued only to the validated (approved) students of respective Institutes / Centers after due verification. Institutional Heads are requested to take note of the above and do the needful.
